The Jonathan Pasco restaurant collection consists of documents and photographs that were previously framed and hung on the walls of Jonathan Pasco's restaurant, which stood at 31 South Main Street in East Windsor, CT. Most of the documents name members of the Lord family, and they may relate to the property on which Jonathan Pasco's restaurant stood. For example, one envelope reads, "Pascoe lot deed transfer to B.W. Lord."

The documents include: deeds, receipts, envelopes, loan documents, and Mason (Freemason) membership documents for B.W. Lord and Frederick Earle Lord. Also included are two photographs: one of an unidentified man in a military uniform that man be a World War I Army uniform, and an image of the Broad Brook Military Band. These documents appear to have primarily originated in East Windsor, CT.

Named individuals on the documents include: H.O. Allen (East Windsor town clerk), Emery O. Bancroft, Mahlon H. Bancroft (notary), Mary S. Bancroft, Joseph A. and Cecelia B. Barber, Minnie M. Buck, May B. Judd, B.Wilson Lord, Frederick Earle Lord, Albert J. Stevens, Estelle H. Stevens, Edwin F. Thompson (East Windsor selectman), and Lewis H.J. Wiebe.

Named business or institutions include G. Fox & Company, Grand Lodge of Massachusetts, First National Bank, Morning Star Lodge No. 28 of Free and Accepted Masons, Suffield Savings Bank, and Windsor Locks Trust and Safe Deposit Company.
